### FILE YOUR ANNUAL REPORT AND PAY BUSINESS ENTITY TAX

This application is available daily between 8:00 am and 11:45 pm Eastern Time. Only use the English version of characters when entering data, otherwise it may cause an inaccurate record on your Annual Report.

## Corporate Annual Report Information and Franchise Tax Fees

---


### Corporate Annual Report

All active Domestic Corporation Annual Reports and Franchise Taxes for the prior year are due annually on or before March 1st and are required to be filed online. Failure to file the report and pay the required franchise taxes will result in a penalty of \$200.00 plus 1.5% interest per month on tax and penalty.

### Annual Report Filing Fees:

- Exempt Domestic Corporations – \$25.00.
- Non-Exempt Domestic Corporations – \$50.00.

### Franchise Tax Rates:

The minimum tax is currently \$175.00, using the Authorized Shares Method and the Minimum Tax using the Assumed Par Value Capital Method is \$400.00 with a maximum tax of \$200,000.00 for both methods unless it has been identified as a [Large Corporate Filer](#) , then their tax will be \$250,000.00. Taxes are assessed if the corporation is active in the records of the Division of Corporations anytime during January 1st through December 31st of the current tax year.

## Foreign Corporations

---

Foreign Corporations must file an Annual Report with the Delaware Secretary of State on or before June 30 each year. A \$125.00 filing fee is required to be paid. If the Annual Report and remittance is not received by the due date, a \$125.00 penalty will be added to filing fee.

## LLC/Partnership Tax Information

---

All Domestic and Foreign Limited Liability Companies, Limited Partnerships, and General Partnerships formed or registered in Delaware are required to pay an annual tax of \$300.00. There is no requirement to file an Annual Report.

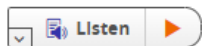

The annual taxes for the prior year are due on or before June 1st. Failure to pay the required annual taxes will result in a penalty of \$200.00 plus 1.5%

# How to Calculate Franchise Taxes



Effective January 1, 2018, a domestic stock or non-stock for profit corporation incorporated in the State of Delaware is required to pay annual franchise tax. The minimum tax is \$175.00, for corporations using the Authorized Shares method and a minimum tax of \$400.00 for corporations using the Assumed Par Value Capital Method. All corporations using either method will have a maximum tax of \$200,000.00. Corporations owing \$5,000.00 or more make estimated payments with 40% due June 1st, 20% due by September 1st, 20% due by December 1st, and the remainder due March 1st.

The Annual Franchise Tax assessment is based on the authorized shares. Use the method that results in the lesser tax. The total tax will never be less than \$175.00, or more than \$200,000.00.

### Non-Stock for Profit

All non-stock, for profit entities that do not comply with the Exempt Corporation requirements will be required to pay a Franchise Tax of \$175.00

### Authorized Shares Method

For corporations having no par value stock the authorized shares method will always result in the lesser tax.

- 5,000 shares or less (minimum tax) \$175.00.
- 5,001 – 10,000 shares – \$250.00,
- each additional 10,000 shares or portion thereof add \$85.00
- maximum annual tax is \$200,000.00

### For Example

A corporation with 10,005 shares authorized pays \$335.00(\$250.00 plus \$85.00).

### Assumed Par Value Capital Method

To use this method, you must give figures provided in your Annual Franchise Tax Schedule L (Federal Return) relative to this method is \$400.00 per million or portion thereof dividing the assumed par value capital

The example cited below is for a corporation with 1,000,000 shares of stock with a par value of \$5.00

1. Divide your total gross assets by your number of authorized shares.  
Example: \$1,000,000 assets, 485,000 shares = \$2,061.856
2. Multiply the assumed par by the number of issued shares.  
Example: \$5.00 x 485,000 shares = \$2,425,000
3. Multiply the number of authorized shares by the assumed par value.  
Example: 485,000 shares x \$5.00 par value = \$2,425,000
4. Add the results of #2 and #3 above.  
Example: \$2,061,856 plus \$2,425,000 = \$4,486,856
5. Figure your tax by dividing the assumed par value capital by the number of authorized shares and multiply by \$400.00.  
Example: 4 x \$400.00 = \$1,600.00
6. The minimum tax for the Assumed Par Value Capital Method is \$200,000.00.

NOTE: If an amendment changing your stock is filed, the tax for the days of the amendment must be given for each day of the amendment then prorated for each portion of the year dividing the tax calculated for that portion of the year. The total tax is the sum of the taxes for each portion of the year.

### Reminder: All Filings and Contents are Available to the Public

Filings and information contained in filings you submit to the Secretary of State are public record, including names, phone numbers, email addresses, and mailing and street addresses, except as provided in statutes. To avoid issues related to identity theft you should avoid using and submitting confidential information in public filings unless specifically required by statute. The public can view information and download documents contained in the Secretary of State's electronic records using digital search tools and information posted on the Secretary of State's website. Also, please note that individuals and private companies use this public information to create third party access to these records.

### Electronic Signatures

"Electronic signature" typically is defined as meaning an electronic sound, symbol, or process attached to or logically associated with an electronic record and executed or adopted by a person with the intent to sign the electronic record. An electronic signature may be as simple as typing in a name electronically, checking a box indicating an intent to sign or some similar process. However, electronic signatures only are permissible in electronic transactions between consenting parties. The use of an electronic signature requires the

# STARTING A BUSINESS CHECKLIST

Thank you for your interest in registering a business with the California Secretary of State's office and processing millions of filings and records requests each year.

There are several key steps to launching a business in the state of California. These steps will vary depending on the business you are starting and the location where the business will be located. Therefore, be sure to check specific rules and regulations within the requirements regarding zoning, licensing, employment, permits and taxes. The "Starting a New Business Checklist" assesses how to start a business in California, not as a direct step-by-step guideline. In order to start a business in California, a business must provide to state, local, and federal agencies.

1. Prepare and Plan (do market research and create an outline of your business)
2. Secure Financing (if necessary)
3. Choose an Entity Type (e.g. LLC, Corporation, LP, LLP, GP, or Sole Proprietorship) and Business Name
4. Register Your Business with the Secretary of State (LLC, Corporation, LP, LLP or GP)
5. Register a Fictitious Business Name (if necessary)
6. Choose a location and check local zoning regulations
7. Obtain specialty licenses and permits (if necessary)
8. Employer Responsibilities (if necessary: EIN Number, workers' compensation, etc.)
9. Tax Information (FTB, BOE, EDD, IRS)
10. Ongoing Secretary of State Filing Requirements (Statements of Information)

#### WHAT IS IT?

This section will tell you how a Fictitious Business Name is defined, as well as who should file a Fictitious Business Name Statement.

The Definition of Fictitious Business Name is:

A business name that DOES NOT include the surname of the individual owner, AND EACH of the partners or the nature of the business is not clearly evident by the name.

For example:

Doing business under a name like:

*Eisenberg & Yandall Associates*

or

*Eisenberg & Yandall Sons*

would require a Fictitious Business Name be registered, even though the surname of the owner is stated, the words following the surname suggest other owners that are not specifically named.

HOWEVER, doing business under a name like:

*Teresa Fiske Plumbing*

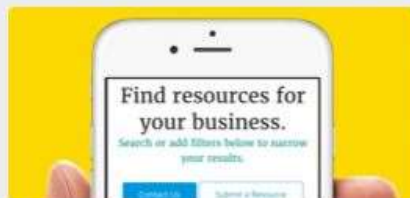

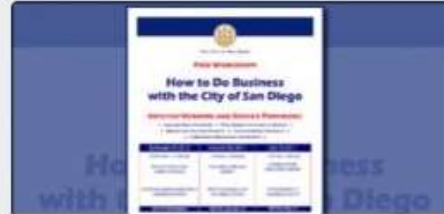

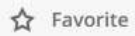
