## You get what you pay for

### Issues to think about

- Author/Creator
- Date of sample
- Contract style/clauses
- Content
- Industry
- Guidance/Analysis

## Fee-based places to obtain K samples and guidance

- Bloomberg Law (forms + analysis)
- Westlaw = Practical Law Company (forms + analysis)
- Lexis Advance (forms + analysis)
- Legal websites for a \$fee\$/form

#### Quality free sources

<u>State websites</u> have free forms (but no analysis) Print books at your local library have forms (and analysis on how to fill the form in)
