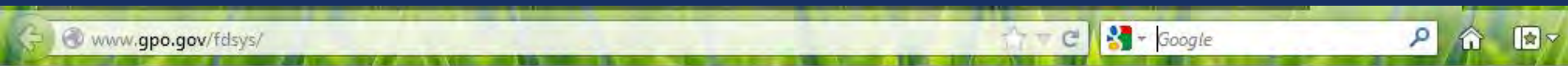

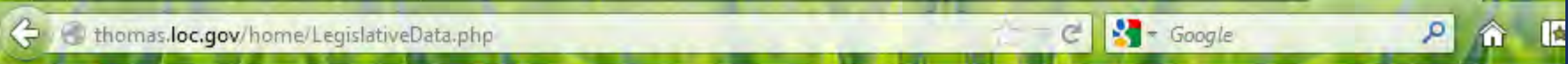

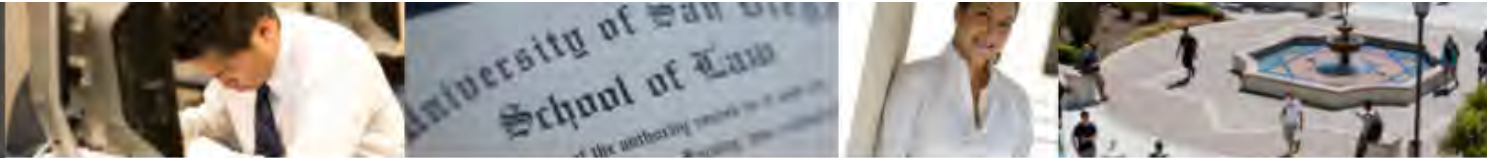

## VIII. POTENTIAL BENEFITS AND RISKS OF SEEKING WRIT

### §17.34 A. Benefits of Seeking Writ

There are several significant benefits to seeking writ review. An extraordinary writ can:

- **Dispose of or narrow issues.** If an appellate court issues a writ, it may dispose of the dispute and avoid a costly trial. Even if a writ does not resolve all issues, it may narrow them so the dispute is more readily settled or tried, or it may provide the trial court with guidance to avoid error at trial.
- **Promote settlement.** A writ petition that persuasively shows weakness in the adversary's case can promote settlement even if the court of appeal summarily denies the petition.
- **Test new legal theories.** Important issues of widespread public interest and issues of first impression are properly raised in petitions for extraordinary relief. If such an issue is raised by an order sustaining a demurrer without leave to amend or granting a summary judgment motion, and the plaintiff can appeal from the resulting judgment, an appellate court will likely be inclined to deny the petition because the appeal is an adequate remedy. When such issues arise in other contexts, however, counsel should consider filing an appellate court writ petition to urge the court to adopt a well-reasoned, innovative solution to an important legal issue, especially if it is an issue of widespread importance.

**JUDICIAL PERSPECTIVE:** When applicable, the writ petition should discuss the policy reasons calling for writ relief in that particular case, e.g., the resolution of conflicts in the law, the avoidance of a costly trial, or the inadequacy of a resolution by appeal. Whatever the argument, the petition should be direct, concise, and to the point.

**CAUTION:** A writ may win a battle but lose the war. For example,
