Getting a job & building your career

- Identify which firms handle clients, legal issues you're interested in
- Identify trends, emerging issues to start establishing your area of expertise
- Impress prospective employers with your knowledge of cases they're handling, current events in the practice area
- Establish a habit of looking for emerging legal issues and strategic thinking

### Why Set up Alerts Now?

### School

- Good fodder for seminar paper and journal note topics
- Opportunity to practice your legal analysis on real world issues—helps solidify your understanding

## What Kind of Alerts?

• When a new case has been filed

- Involving a certain party, attorney/firm, jurisdiction, cause of action, etc.
- When new documents have been filed in a case you're following
- New statutes and regulations affecting your practice area
- Updated KeyCite/Shepard's report
- Legal and non-legal news and analysis about a certain industry, company, or person
- New issue of a publication you follow

#### Supreme Court Unanimous in Rule That Patentee Has Infringement Burden in DJ Case

Medtronic, Inc. v. Mirowski Family Ventures, LLC, U.S., No. 12-1128, 01/22/14 Key Holding: A unanimous Supreme Court reverses the Federal Circuit's burden-shifting rule when a licensee seeks a declaration that new products do not infringe the licensor's patents. Key Takeaway: A patentee retains the burden to show infringement in a declaratory judgment action brought by its licensee.

When a licensee seeks a declaration that its newly introduced products would not be covered by the claims of licensed patents, the patentee nevertheless continues to bear the burden of persuasion that the new products infringe, according to a Jan. 22 decision by the Supreme Court (Medtronic, Inc. v. Mirowski Family Ventures, LLC, U.S., No. 12-1128, 01/22/14). Justice Stephen G. Breyer wrote the opinion for a unanimous court, reversing a decision by the U.S. Court of Appeals for the Federal Circuit that shifted the burden when the license agreement did not allow the patentee to counterclaim infringement.




