

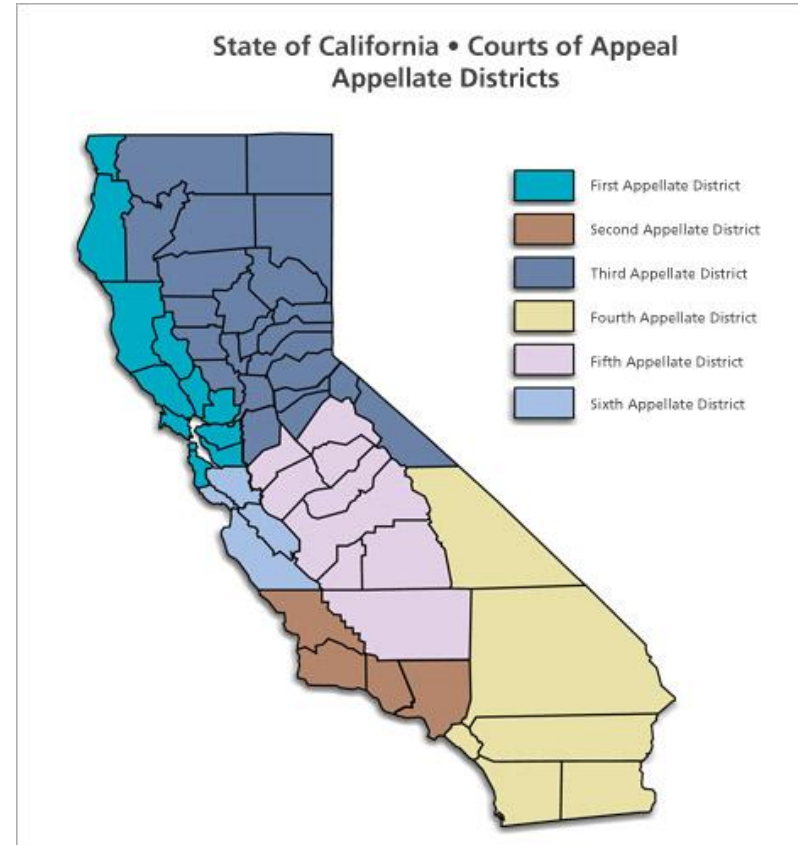

California Courts

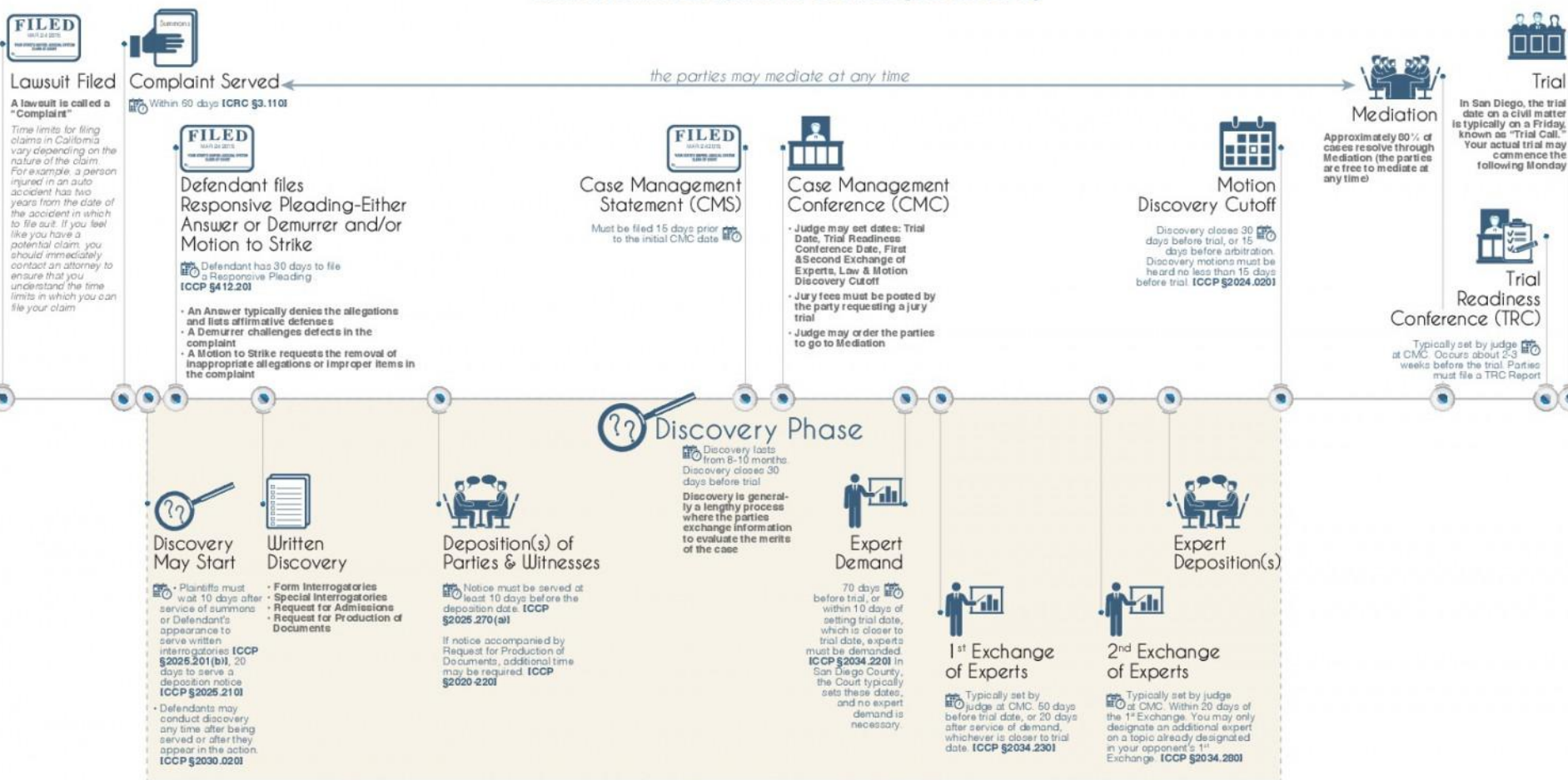
- Superior Courts
 - 58 courts, one in each county
- Courts of Appeal
 - 3 member panels
 - 6 districts divided geographically
- Supreme Court
 - Chief Justice and 6 Associate Justices
 - Regular sessions in San Francisco, Los Angeles, and Sacramento
 - Review of the Courts of Appeal is discretionary (writ of certiorari must be granted)
 - Typically only granted to speak to public policy issues or to resolve conflicts between the Courts of Appeal



California Civil Litigation Timeline

(Getting to trial may take 1-2 years or longer)

Five Year Rule. An action shall be brought to trial within five years after the action is commenced against the defendant. [CCP §583.310]



The example used in the timeline above is a San Diego County Example

CCP—California Code of Civil Procedure
CRC—California Rules of Court
Gen. Jurisdiction—When complaint demands damages in excess of \$25,000

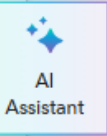
