RESEARCHING YOUR TOPIC

Reliable sources



- Evaluate sources for:
 - Authority author is identified, reputable, credentialed
 - **Objectivity** fairness, lack of bias
 - **Accuracy** provides references to sources, verifiable
 - Scope relevant to your topic and argument
 - **Currency** may vary by topic, but make sure you know the current state of thinking in your field (even if it's rooted in older writings)

- Use multiple search techniques
 - keyword (natural language or terms & connectors)
 - subject
 - browse
- Ask a librarian
- Build from the sources you've already found
 - look at sources cited by those sources
 - use a citator (Shepard's or KeyCite) or Cited By on Google Scholar to find sources that have cited to sources you've already found


