# Existing Scholarship

- Look at existing articles from relevant journal articles (law or another discipline) to see if the author(s) suggest other topics of exploration.
  - See what the author(s) says is outside the scope of the article or need to be explored in more depth.
  - Often mentioned in introduction or conclusion.

# Literature Review

# What is a lit review?

- A survey of books, scholarly articles, and any other sources relevant to a particular issue, area of research, or theory.
- Helps you formulate your thesis and locate your arguments within the larger field of study.

# Reliable Sources

- Evaluate sources for:
  - **Authority** – author is identified, reputable, credentialed
  - **Objectivity** – fairness, lack of bias
  - **Accuracy** – provides references to sources, verifiable
  - **Scope** – relevant to your topic and argument
  - **Currency** – may vary by topic, but make sure you know the current state of thinking in your field (even if it's rooted in older writings)

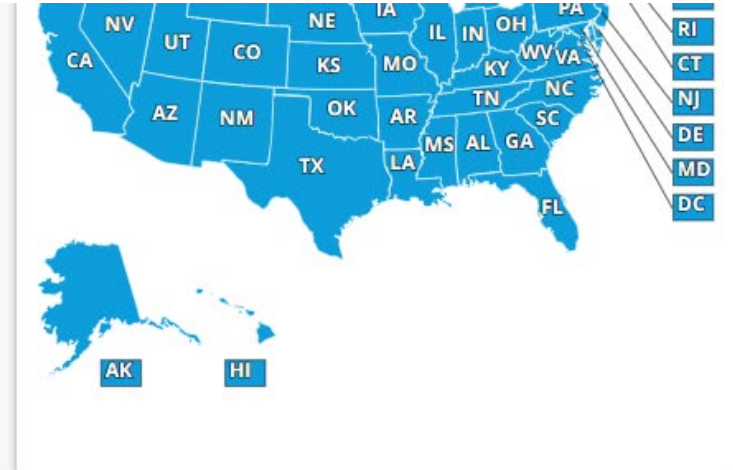

Abortion and reproductive rights have been inextricably linked since the earliest years of American history. During the colonial era, inducing abortion with medicinal, herbal remedies was common practice. Male physicians were not often utilized in abortion procedures from this time through the 1800s. Midwives, who were sometimes enslaved women, would perform these procedures on white women, though laws prohibited enslaved people from participating in abortion. Thus began a long discrepancy between the kinds of healthcare afforded the white population in the U.S. compared to BIPOC (Black, Indigenous, people of color) populations.

The first state law to restrict abortion was passed in Connecticut in 1821. The law allowed abortion prior to "quickening," the term used to note when fetal movement can be felt by the pregnant person. This usually occurs between thirteen and twenty weeks into a pregnancy. Several other states followed suit in the coming decades, including New York, which made post-quickening abortions a felony in 1829. Restrictions on abortion were brought forth by different motives, some of which were of concern for the health and safety of those procuring abortions. Other concerns were spurred by eugenic fears about the decline of the white population in relation to the growth of immigrant populations. Eugenicists thought that people with physical, moral, or mental disabilities, as well as foreign nationals and BIPOC populations, did not contribute to the "greater national race" and deemed such persons undesirable. Generally, abortion before quickening was still available until the 1870s, though civil fines were sometimes imposed.

In 1873, Anthony Comstock, the head of the Committee for the Suppression of Vice, rallied behind legislation that made it illegal to disseminate information informing the public of abortion and contraception through the mail. This legislation, known as the [Comstock Act](#) deemed such information as "obscene, lewd or lascivious, immoral, or indecent." The law was challenged by Margaret Sanger, the founder of Planned Parenthood, amongst others, though it was never repealed. Sanger worked to provide information on contraception and reproductive services to women during this time, despite the Comstock Act. Though she

The essay argues that a multi-faceted commitment to dignity links *Carhart* and the *Casey* decision on which it centrally relies. Dignity is a value that bridges communities divided in the abortion debate, as well as diverse bodies of constitutional and human rights law. *Carhart* invokes dignity as a reason for regulating abortion, while *Casey* invokes dignity as a reason for protecting women's abortion decisions from government regulation. This dignity-based analysis of *Casey/Carhart* offers principles for determining the constitutionality of woman-protective abortion restrictions that are grounded in a large body of substantive due process and equal protection case law. Protecting women can violate women's dignity if protection is based on stereotypical assumptions about women's capacities and women's roles, as many of the new woman-protective abortion restrictions are. Like old forms of gender paternalism, the new forms of gender paternalism remedy harm to women through the control of women. 

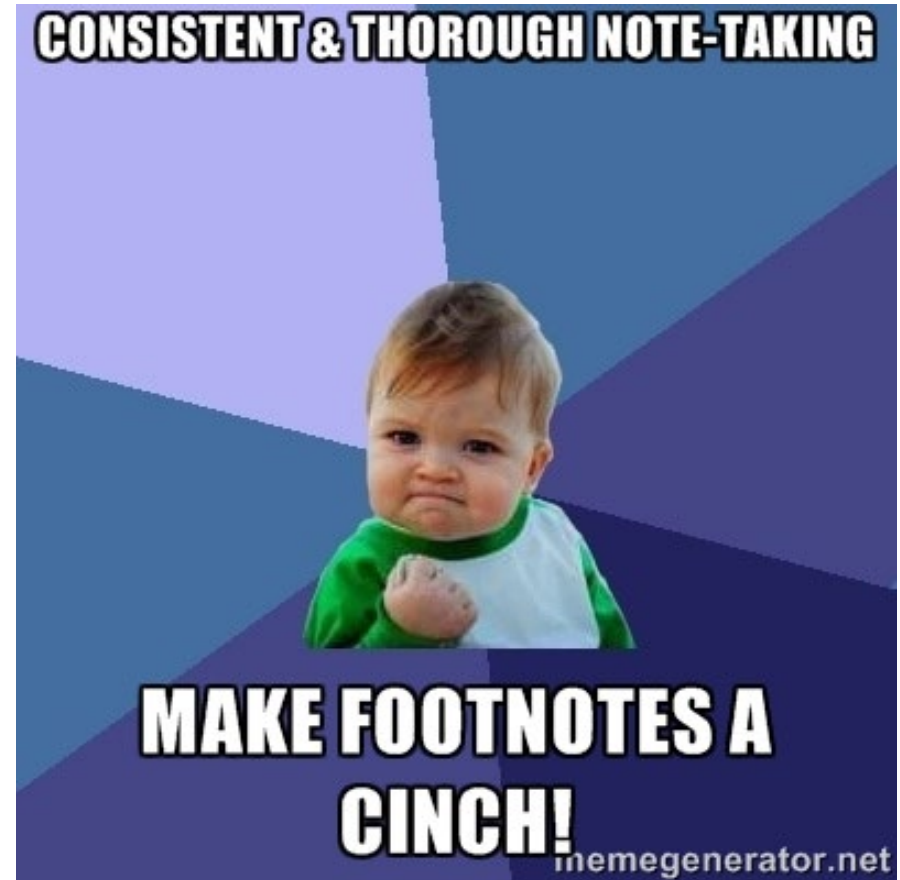

# Citing the best source

- Don't rely on Source A to tell you what Source B says – go back to the original
  - Don't cite Scholar A to tell your reader what Scholar B argued
  - Don't cite a book or an article to tell your reader what a case held
  - Don't cite a case to tell you what the statute says

- Author (if any)
- Title of article or page
- Publication/Organization/Sponsor
- Date
- URL
- Archive of page (Perma.cc or Internet Archive)

When in doubt, more info is better!
